Thank you for consulting me on this application. I was consulted prevalidation and determined that a bat survey was not required to accompany this application since the extension was lower than the roof and not breaking into the existing wall, plus the widening of the door is minor and low level. I have no objections to the proposals and my only comment would be regarding the lighting of the facility. I note that they are intending to have limited lighting and I would advocate that as much as possible is on timer and or motion operated to prevent disturbance to bats and other nocturnal wildlife.

I do have some additional comments regarding the operation of the distillery, which we should perhaps bring to the applicants' attention as they may be relevant in the future operation of the business and may require further consents. I know the applicants are currently propagating some juniper from the existing plants on the estate with help from Natural England and the National Park Authority, but I would like to be assured that any collection of berries and management of the existing shrubs is sustainable. Some of the plants are found within the Simonside Hills SAC and collection from these will require consent (as would the collection of any plant material from within this area). The recent new water supply route that has been given approval is abstracting water from within the SAC and although the new supply was deemed acceptable by the Planning Authority and Natural England, if there is to be increased abstraction from this source to serve the distillery, this may require additional consents. The information regarding waste water is to discharge via the existing sewage package treatment site, but the details for this seem only to be regarding the increase in use for the additional workers at the site (which seem acceptable). If there is to be any waste water discharge from the distilling process, what would this contain and where would this go? Watercourses surrounding the property discharge into the River Coquet SSSI and I would like to ensure that there is no possibility of any effluent making its way into the watercourses.
