1. The development hereby permitted shall be begun before the expiration of three years from the date of this permission.

Reason: To ensure that the development is commenced within a reasonable period of time from the date of this permission and to comply with Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990 (as amended by Section 51 of the Planning and Compulsory Purchase Act 2004).

Reason: For the avoidance of doubt, to enable Northumberland National Park Authority to adequately control the development and to conform with Policies 1, 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

3. The timber cladding to the north wall is to be retained and reinstated upon substantial completion of the approved works to this wall, using the original panelling, except for where the pulpit, new doorway and wood burning stove will be located.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

4. Prior to the commencement of development, details of a mortar mix and method of application for repointing shall be submitted to, and approved in writing by, the Local Planning Authority.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

5. Prior to the commencement of development, samples of stone shall be submitted to, and approved in writing by, the Local Planning Authority.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

6. Prior to the commencement of development, details of slate vents shall be submitted to, and approved in writing by, the Local Planning Authority.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

7. Prior to the commencement of development, extract fans and flues shall be submitted to, and approved in writing by, the Local Planning Authority.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

8. Prior to the commencement of development, details of the balustrade for the internal staircase shall be submitted to, and approved in writing by, the Local Planning Authority.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.

9. The development shall be carried out in strict accordance with the mitigation measures and method statement set out in the E3 Ecology Ltd Bat and Barn Owl Survey received on 28th October 2013.

Reason: To ensure the development poses no risk to roosting bats (or other protected species) and to ensure the development is in accordance with Policy 17 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document.

10. Prior to the commencement of development, details of the new external door to the rear (North) of the building, to match the front door shall be submitted to, and approved in writing by, the Local Planning Authority.

Reason: To ensure works are carried out in a manner consistent with the character of the building and to ensure the proposals accord with Policies 3 and 18 of the Northumberland National Park Authority Local Development Framework Core Strategy and Development Policies Document and the National Planning Policy Framework.



Informative Notes:

- **1.** This Listed Building Consent is granted in strict accordance with the approved plans. It should be noted however that:
 - (a) Any variation from the approved plans following commencement of the development, irrespective of the degree of variation, will constitute unauthorised development and may be liable to enforcement action.
 - (b) You or your agent or any other person responsible for implementing this consent should inform Northumberland National Park's planning authority immediately of any proposed variation from the approved plans and ask to be advised as to the best method to resolve the matter. Most proposals for variation to the approved plans will require the submission of a new application.
- 2. This consent is granted subject to conditions and it is the owner and the person responsible for the implementation of the development who will be fully responsible for their compliance throughout the development and beyond. If there is a condition that requires work to be carried out or details to be approved prior to the commencement of the development this is called a "condition precedent". The following should be noted with regards to conditions precedent:
