14NP0079 - Dismantle existing Kingspan KW6 domestic wind turbine and re-erect in new location at Uswayford Farm, Harbottle, Morpeth, Northumberland, NE65 7BU

Thank you for bringing to my attention the amendment made to application 14NP0079 that I have previously commented on, see attached.

I understand that the proposed turbine at Uswayford will now be mounted on the existing 9 meter tower rather than on a new 15 meter tower as previously indicated in the drawings submitted with the application.

I can confirm that I have no objections to this revised specification, indeed it is likely to have less of an effect upon the landscape character and views of this part of the National Park and I welcome the clarification and reduction in height of the structure.

The only point that I would add to my previous comments is whether consideration should be given to the removal of the concrete footing found at the current turbine location. Should permission be granted to relocate the turbine, the existing footing will become redundant and I would suggest that condition 5 of planning application 12NP0007 is therefore likely to come into play.
