Hi Sam

As discussed, excavation and undergrounding works in this area would require the submission of a plan/specification of the excavation and re-consultation with English Heritage and NNPA Historic Environment Officer. This would cause delays to the application and may or may not lead to a change to their existing comments.

Having spoken with Colin Wilson this morning, he has suggested that an alternative option would be to take the cable overground, which would avoid the need to re-consult heritage consultees and remove the risk of any heritage impacts. If your client wants to go ahead with the overground option, I think confirmation that the cable would link between the building and the cabins, the approx height of the cable and type of cable/method of connection proposed (if known) should be adequate information.

If you could confirm this ASAP that would be helpful. I have to have my report on this completed by Tuesday if it is to go on the agenda for DMC, so if you could let me know by Monday that would be appreciated.
