Gleedlee forest has a felling licence for clear fell. In order to economically extract the timber, a 400m road is required to take timber wagons into the centre of the forest, with a turning and stacking area at the end. Rock to build the road is to be dug from exposed bedrock adjacent to the road and within the forest, and hard aggregate to surface the road will be imported.
Northumberland County Council timber transport liaison have agreed the route for the wagons collecting the timber.
