2. Recommendation

3. Reason for Recommendation

Hesleyside is one of the most significant historic places in the National Park, the house dating from the 14th century with 17th and 18th century additions. The landscaped park dates to the 18th century and the management of which refers to a plan of 1776. The woodland is classified as pre-1860 according to the Northumberland Historic Landscape Characterisation, however this proposal relates principally to the facilitation of timber extraction within an area of modern commercial forestry.

This work related to an approved woodland management plan which in turn refers to the Heritage Undertakings Plan with regard to the conservation and enhancement of the Hall, associated buildings and historic parkland. This should be adhered to.

There is a low likelihood of minor-adverse impacts to the setting of the hall and historic parkland during the construction of the proposed roads and during timber extraction. However, these will be temporary and will not cause significant harm in the long term.
