14NP0098 - Construction of a metal framed and metal clad shed 9m by 5m by 3m height to eaves at Redeswire, Rochester, Newcastle upon Tyne, NE19 1RH

Thank you for consulting me on the above application. I wish to make the following comments on the potential landscape, lighting and tree implications associated with this proposed development.

• I can confirm that I do not believe that the proposed development will have a significant effect upon the landscape character or views of this part of Northumberland National Park. The nearest publicly accessible receptor site is the A68 road lying approximately 4 metres to the north of the proposed development but views of the shed from here will be transient and partially screened by an existing stone wall. I note the intention to use green metal clad sheets for the walls and roof and can confirm that this will help mitigate the visual effects of the building within its landscape setting. The proposed building will be set low down within the landscape and will not directly affect the skyline when viewed from the A68.

• The applicant has not indicated the need for any additional external lighting within the application thus the dark skies status of the National Park should not be threatened by an increase in light pollution as a result of this proposed development.

• The applicant has indicated within the application form and checks have confirmed that the proposed development will not affect any notable trees or hedges. Given the nature of the work identified within the application I do not believe that a tree survey and tree protection measures are required in this case.
