3. Description of the Proposal

Please describe the proposed development, including any change of use:

Changing a 3-unit (disused) stable to house 2 wood-pellet biomass boilers in the central unit with an 8-ton pellet fuel store in the units to either side. A generator will be housed in a small enclosed structure attached to the south end which will run the boilers in the event of a power cut. Two flues, one for each boiler, will project 2.1 metres from the roof of the central section. Both have been powder-coated slate grey in order to blend in with their surroundings. The stable building has been insulated throughout with fire-retardant panels. Two trenches are being dug across the courtyard to bring the hot water into the residence. There are trees between the stable and the property boundary such that the flues will be barely visible, even in winter.
