Location:Hesleyside Hall, Bellingham, Hexham, Northumberland, NE48 2LAProposal:Erection of one `hut on wheels` to provide tourist accommodation

I refer to the above planning application consultation received on 5 February 2015 in respect of the above development.

In making our response the Highway Authority assess the impact of any proposed development on the highway network, both during construction, and once a development is completed. To ensure the highway network in the area can accommodate the anticipated trip generation, adequate manoeuvring/parking space is provided, safe access can be achieved, the highway remains free for the passage of all users of the highway, and so it does not have an adverse impact on the safety of all users of the highway.
