Please describe the proposed development, including any change of use:

This property includes a (currently unused) walled garden approx. 50 meters square, dating from the construction of the main house in 1866. We want to bring it back into organic vegetable production, and in order to extend the growing season wish to erect two polytunnels, 18 x 36ft and 18 x 30ft respectively. At the ridge, their highest point, they will be no taller than 9ft. The existing wall all the way round the garden is 9ft tall so the polytunnels will not be visible from outside.

Polytunnels are totally silent and the covers can be recycled. We want to involve local schools in growing food and hope to encourage children to grow their own vegetables by offering them garden space. I've written two books on domestic polytunnel vegetable growing and would like to see more people take control of the production of the food they eat.
