Dear Chris,

I have no objection to this proposal. The site is within the archaeologically sensitive area shown on the Alwinton Village Atlas, however, the footprint of the proposal and the use of lightweight materials not requiring substantial excavated foundations will in practice result in low potential for harm to any surviving archaeological deposits in this area. There is a building on the footprint of the main house on the 1860 Ordnance Survey map, though the building itself is not considered of sufficient interest to be of local significance.

Therefore I consider that it is neither reasonable nor proportionate to object nor require a programme of archaeological work for this application.
