I note the seed mix and think that the species suggested are appropriate for the conditions and location. The timing of seeding and in the autumn and checking in the spring with re-seeding as necessary is satisfactory. I am also content that the maintenance strategy and design of the track construction will ensure that excessive run-off and impact on the SAC is unlikely. The point describing that the maintenance will be on-going to maintain the vegetation cover and the track form as shown is welcomed to ensure this in the future.
