Details of Proposal

This application seeks to approve details required by condition 3 (seeding of the track) and condition 4 (ongoing maintenance) of 15NP0030, to construct a new upland track, running from the north of Cold Law, towards Broadstruther.

The application documents set out an outline specification, seed mix and a methodology for seeding, aftercare and longer term management, providing details for the initial seeding of the track and specified maintenance in the spring following completion.

Summary of Consultations/Representations

NNPA Ecologist: No objection. The seed mix is appropriate and timing of seeding and checking is satisfactory. Maintenance and design will prevent excessive run-off – impact on the SAC is unlikely.

NNPA Access/Recreation Officer: No comments.

NNPA Landscape/Forestry Officer: No objection. Principle of the proposed work is in line with expectations. Rewording of a small part of the seeding/aftercare section is suggested.

Natural England: No comments.

Assessment

Condition 3 (seeding) was required in order to protect the landscape character of this part of the National Park. Condition 4 (ongoing management) was required, again to prevent any unacceptably damaging effect on the landscape character of the National Park, but also to ensure that the proposal does not give rise to unacceptable impacts on the River Tweed SAC. Therefore, the landscape and ecological effects of these proposed details are the key material planning considerations to be considered.

Condition 3

A seed mix, methodology and timescales for this work have been supplied by the applicant as required by condition 3. Natural re-vegetation and replaced turfs that have been cleared prior to the soil reversal works are proposed as the main source of providing the vegetation on the surface of the track. This would be complemented by a nurse seed mix immediately after works. Upon completion of the works, the track would be seeded with a highland grass mix, to a specification set out.

The Landscape Officer has agreed that what is proposed is appropriate and the details are considered to enable the track to accord with Core Strategy Policy 20.

Condition 4

A scheme for ongoing maintenance has been provided. Following the re-seeding that will be carried out upon completion, there would be a review of this in the spring, following completion of the works, with any remaining areas of bare ground to be seeded once more. No additional specific ongoing maintenance is provided, although a more general indication of future management is also provided.

Both the Landscape Officer and Ecologist have accepted that the details proposed are appropriate. The details are considered to enable the track to accord with Core Strategy Policy 20 in terms of its potential effect on landscape character. The Ecologist has confirmed

that excessive run-off and effects on the SAC would be unlikely and therefore the proposal is considered to accord with Core Strategy Policy 17.

Recommendation

Conditions 3 and 4 are hereby discharged, subject to implementation of the development in accordance with the submitted details set out in *Landscape Mitigation and Management Proposals 99870/8014 Revision A* received on 1st October 2015.
