Dear Rebecca

I am responding on behalf of the Councillors of Otterburn Parish Council to both applications 15NP0080 and 15NP0081.

The Councillors discussed both retrospective applications at the recent meeting and after a couple of them had visited the location.

There is concern over what they believe is that the decking has taken a much bigger footprint than should be permitted. The decking covers a very large area in comparison to the size of the lodge.

There is also concern over the look of the lodges that they are not in-keeping with the location and other developments on Otterburn Hall estate. It is understood that the lodge with no present fencing round the decking is proposing to add a bright white 'guard' that if true will further evidence it is believed that the development is not appropriate for the location.

I reported the likely reason for these retrospective applications after our call and while noted the Councillors wish to record that the Parish Council object to the applications.

Whilst it is noted that hot tubs are not apparently subject to planning application the Councillors have asked me to report their concern over the number of these being installed on Otterburn Hall estate. It is well documented that the water and foul water infrastructure is not adequate for the current properties on the estate and adding hot tubs as well as possible additional lodges will have a further adverse effect on the estate.

It is assumed the National Park do have Officers visiting the site to ensure development is appropriate for the resources available and they have asked me to seek reassurances that this has been undertaken recently and if so what was the report following the visit.
