Dear Rebecca,

I have noticed that the River Tweed SAC is not noted as a constraint on the County's website despite the site being approximately 50m from the river (which moves a lot). This means that I don't know whether Natural England will have been consulted. The ecological report does mention the fact that there is an SAC but only assesses the impact of the physical building on the site. There is no mention of the sewage treatment in the ecological report and possible impact on the SAC, despite other information showing that a package treatment will discharge into the River Breamish. I suggest that the County ecologists have a look at this application and they will probably have to consider a Habitats Regulations Assessment.
