I would therefore hope that the County Ecologist, Natural England and Environment Agency have been consulted to ensure that the construction of the facilities, sewage treatment, construction and operation of the fishing lake will not impact on the water quality or increase siltation of the river. Although not designated as a SSSI or SAC this river holds the only population of this endangered invertebrate in Northumberland, which is listed on Schedule 5 of the Wildlife and Countryside Act and is a species of principle importance under section 41 species on the NERC Act.
