Thank you for consulting me on the above planning application.

From a landscape perspective I believe that the materials identified for this proposed development are appropriate and in keeping with a similar but smaller agricultural storage shed situated just north of this proposed development. The principal receptor site for this development will be the minor county road leading from Lanehead to the Tarset bridge and is located approximately 80 metres from the site. I do not believe that there will be a significant effect upon the landscape character or views of this part of the National Park as a result of this proposed development.

The applicant has indicated that no new lighting will be required for this development and therefore the Dark Sky Park status of the National Park will not be affected as a result of this application.

With respect to the impact upon trees, I note that there are a couple of semi-mature trees to the south and east of the proposed application site. Whilst I would not regard these as being notable specimens and they are not located directly on the application site, care should be taken not to damage these during the construction period should this application be approved.

I can confirm that I have no objections to this proposed development.
