### **RECOMMENDATION:**

**Substantive concern (Apply Conditions):** a significant concern which might be overcome with a change to the scheme, or the imposition of a planning condition

#### Assessment of proposal:

It is considered that the proposed development in highway terms with the National Planning Policy Framework.

The proposed would see a change of use from a workshop to 2 no. 1 bedroom holiday lets. This proposed would see a minimal increase in trip generations to and from the site which would have no adverse effect on the wider highway network.

The existing access will be utilised for the development and is currently in an acceptable state and does not need upgrading.

Car parking has been indicated on the proposed plans but has not been marked out clearly. For 2 no. 1 bedroomed holiday lets, 1 parking space per unit will be required. However, even though parking spaces have not been shown in detail on submitted drawings there is enough space within site curtilage to incorporate 2 parking spaces and suitable manoeuvrability so that vehicles can exit the site in a forward gear.

No details have been submitted in regards to cycle parking. We would highly recommend a form of cycle parking/storage as it supports sustainable modes. We would require a plan showing a form of cycle parking within the site.

Refuse will be stored within the site boundary when it is not due to be collected. The holiday lets will utilise the existing arrangements which serve The Wilderness. No bins are to be stored on the highway except for collection days.

Therefore, we would have no objections to this application being permitted.
