Thanks for your consultation response on this application, much appreciated.

While I appreciate that encouragement of sustainable transport modes is a positive, anything required through conditions needs to be a reasonable and necessary requirement that is essential for the development to be acceptable. I'm not proposing to include cycle parking requirements as a condition, as I don't think that I would be able to argue that cycle parking is essential in this case, bearing in mind the small scale of the development and the fact that the application is otherwise considered to be acceptable in principle, and in terms of parking and effects on the highway network.

For reference, the two additional spaces are included on one of the plans (which I've attached) and would be located to the rear of the holiday lets, although I appreciate that it would have been helpful if these details had been included on the other plans too.
