Thank you for consulting me on this application. I have read the bat report that accompanies this application and as a result I suggest that if permission is granted that the recommendations in section 6 of the report are made a condition including the use of bat friendly timber treatment and membrane and the removal by hand of slates and stone.

I note that on the proposed and existing drawings there is a difference of two small trees despite the application form saying no trees will be affected. I also note a representation that mentions a large copper beech. Aerial and roadside photographs do not make it obvious that there are any large trees that will be affected - there is a beech to the east, but from the drawings I don't think this would be affected. If you can confirm that no trees will be removed I have no objections or further comments.
