Dear Rebecca.

Having looked at the proposals, there is one public bridleway in the immediate vicinity of the site where the proposed realigned section of forwarder track is to be installed. Alwinton Bridleway 14 enters the site from the south, crosses the existing track and runs to the rear of the property at Fairhaugh, heading in a general north-easterly direction towards the footbridge that crosses the Usway Burn.

For information - this bridge was washed out in the December floods and is due to be replaced with a new bridge in late April/early May.

Alwinton bridleway 19 follows the route of the access track on the north side of the burn an links to public bridleway 14 on this side of the Usway burn.

I would like some information on future use of the new Bailey bridge, as currently the existing ford allows access for horse riders and cyclists. Will the specification allow access for those users or will they be prohibited?

I will have no objection to the proposals on the condition that the Public Rights of Way are protected throughout. The planned works must have no effect on accessing these routes. No action should be undertaken to disturb the surface of the paths, obstruct the paths or in any way prevent or deter public use of the paths without the necessary legal diversion or closure order having been made.
