Thanks for consulting me on this forestry determination. In general the replacement of a ford with a bridge is a positive step in terms of water quality as it is likely to reduce siltation on this stretch of the burn. The watercourse is not a SSSI, but does feed into the River Coquet SSSI downstream. I have no objections to the methodology given for the works using oil booms, sedimats etc and therefore have no further comments regarding this aspect. I note Robert's comments regarding the trees adjacent to track and would like to reiterate ensuring protection of these.

With respect to the material used for the track I am happy that it is local material from an ecological point of view - better than importing stone from outside. I note Rob has queried the location of the quarry to provide the stone and if you have any further information and require comments on this element, please let me know.
