Wark footpath 28 enters the site from the east and joins the route of Wark 26 on the north-east side of the property.

I will have no objection to the proposals on the condition that the Public Rights of Way are protected throughout. The planned works must have no effect on accessing these routes. No action should be undertaken to disturb the surface of the paths, obstruct the paths or in any way prevent or deter public use of the paths without the necessary legal diversion or closure order having been made.
