Dear Chris,

I have consulted the Historic Environment Record and confirm there are no recorded sites on the proposed site. The site is situated within the Hadrian's Wall part of the Frontiers of the Roman Empire World Heritage Site, adjacent to the Vallum and Twice Brewed Roman Temporary Camp (Both Scheduled Monuments). I would've liked to have seen greater discussion of the historical development of an Inn on the site of the present Twice Brewed and how this proposal relates to this. This mentions (at the end of the Planning Policy and Heritage Statement) beer brewed here in the 15th century (prior to the Battle of Hexham), but does not utilise map based or photographic evidence from prominent viewpoints in the surrounding landscape, to support the judgements made in this statement with regard to the visual effects arising from the proposal.

Following the submission of further visual information in support of the Planning Policy and Heritage Statement, it is likely that there will be less than substantial harm caused to the setting of the World Heritage Site or to previously unrecorded archaeological remains. However, due to the significance of the site, I recommend that the applicant engage the services of a suitably qualified and experienced archaeologist to monitor intrusive groundworks proposed with this application, to the top of archaeological deposits or the natural substrate, whichever is observed first (a watching brief).
