My only comment would be about the waste water treatment. I note that the existing system is to be utilised and the additional amount of discharge is small in comparison to the existing use, however when I have been to this site in recent times there is definitely a smell coming from the reedbed/discharge area under its current use and I wonder if it is all operating correctly. I am not sure if this is something that can be dealt with under this application or should be investigated via another route?
