I have been asked to return this consultation without comment as it falls below our current risk appetite, however we do have an informative you can add to the decision notice:

Informative :

Private water supplies

Public Protection would recommend that the applicant contact a member of our Private Water Supplies Team on 01670 620374 with regard to The Private Water Supplies Regulations 2016, which came into force on 27 June 2016;

“This legislation requires that each private water supply is subjected to a risk assessment that supplies water to any premises (other than a supply to a single dwelling not used for any commercial activity).”

It also requires the water supply to be subject to routine sampling, the frequency of which will be determined by the classification of the supply. Supplies with a commercial activity [for example B&B, holiday let, Assured Short hold Tenancy (AST) properties] using 10m^3 each day would be subject to annual sampling, with the sampling frequency increasing when consumption is above 10m^3 . Supplies with a domestic only element to them (for example owner-occupied, second homes) and using 10m^3 per day would be subject to sampling every five years at the time of risk assessment.
