Further to our conversation to confirm I have no objection to this application and that an appropriate condition can be utilised to ensure that the structure does not intrude into the setting of the World Heritage Site should the adjacent woodland reach maturity and felling rotation. It is important that the structures are in keeping with the farmstead, but that this does not preclude modern structures which enable the farm to operate efficiently and sustainably.
