Thanks for submitting the application 17NP0005 for condition 20 of The Sill permission for the car parking payment infrastructure. We need some additional information to be able to consider these proposals. The site is located within a sensitive landscape and World Heritage Site, and we need to know exactly what we are considering.

Please could you provide the following:

 Size of the proposed car parking payment units (metric dimensions for height/width/length) – these aren't provided on the specification provided;

H: 2200mm / L:910mm / W:300mm

Confirmation of the proposed colour (RAL or BS if possible) of the car parking payment

units (I would have concerns with purple units, both because of the sensitive location and the conflict this may have with other elements of the scheme such as the signage strategy. Dark grey may be the best colour to use as this should blend in well with the signage strategy. I have spoken to Robert Mayhew who is the Operations Manager and I understand is dealing with the parking payment systems from the NNPA side – he has advised me that it should be possible to get these units in a range of colours;

• Size and materials for the pole for the camera. Technical information on the 'FMS Range' has been submitted, but this has a number of different heights between 3 and 8 metres – it needs to be clearly stated which one is being proposed, and also the finish for the pole (would this be galvanised steel, painted steel, etc).

Please can you get this information to me within the next 7 days, ideally as soon as possible, as I'm holding off from sending out the consultations to the historic environment/landscape consultees until we have this additional information, so that they can properly review the proposals when making their comments.
