I have reviewed the bat and barn owl report submitted with this application and have no objections if the mitigation for both bats and barn owls in section 2 of the report are made a condition. This includes relocating the current barn owl box to a neighbouring barn after checking that none are present before works commence and erecting another box on the edge of the plantation at least 30 days before work commences to provide an alternative roost away from disturbance. Bat mitigation includes retention of an existing crevice and situating a light on a timer away from this.
