Dear Rebecca,
Thanks for consulting me on this application bearing in mind the proximity to the River Coquet SSSI. I don't have any objections as this work is intended to reduce impact of timber extraction on the SSSI by creating bridges rather than using fords across the river. I have tried to check with Natural England to see if they had any comments or advice, but have been unable to contact the relevant officer. As I am aware there is a time limit on this GPDO I thought I should reply now without this; if I get a response in the next few days I will let you know. My only comment is that the proposed works should be carried out before the spawning season to minimise any risk to breeding migratory fish. I see they are intending to finish before the end of September which would be acceptable.
