Please see attached plans to show the underground cable route in relation to the pole positions.

I have also attached a copy of the SMC letter, which does cover the pole removal, under condition (b), suitable Method Statement required (To be submitted to HE (via Mike) in due course).

The underground cable route will be subject to condition (c) with a WSI required (To be submitted to HE (via Mike) in due course).

Checking MAGIC map (see attached) the cable route will be in the Buffer Zone, with 7 poles to be removed from the SM area.


