Relocation and replacement of wood pole No. 5, replacement of wood pole No. 39 and removal of eight wood poles near to the Roman Army Museum, Greenhead, Northumberland, CA8 7JB, as shown on the attached Plans A & B.

In order to maintain the security of electricity supplies in the area Northern Powergrid propose the:

- > Relocation of wood pole No. 5 with new wood 'H' pole and stay wires
- > Replacement of existing wood pole No. 39 with new wood 'H' pole and stay wires
- > Removal of eight wood poles
- > Installation of new underground cable
- > All works to be subject to Archaeological Montitoring (Watching Brief)
