Details of Proposal

This application is for approval of details reserved by condition 6 attached to planning approval 18NP0026, which granted conditional permission for the installation of a 20m high lattice mast on a concrete base accommodating 3no. antennas and 2no. 600mm transmission dishes and associated ground based equipment, including installation of 30m stone access track at Barrowburn Farm, Harbottle. The application site is located within the open countryside approximately 240m north east of Barrowburn farmhouse, which forms part of the MOD Otterburn Army Training Estate.

Condition 6

Notwithstanding the information already submitted making reference to the access track and turning area, prior to the commencement of the construction of the track and turning area hereby permitted, a scheme for the seeding of the surface of the track, including the seed mix, methodology and timescales for this work and details of how the track would be maintained thereafter shall be submitted to and approved in writing by the Local Planning Authority. The track shall be constructed and seeded in accordance with the approved scheme and within the approved timescale, and shall be maintained in accordance with the approved scheme thereafter, to the satisfaction of the Local Planning Authority.



Reason: In the interests of the visual amenity and landscape character of the area and to ensure the development is in accordance with Core Strategy policy 20 and the NPPF.

The condition above was considered appropriate by the Planning Officer and Landscape and Forestry officer given the mast is to be sited in the Upland Burn Valleys Landscape Character Area of the Coquet Valley. The condition was also considered appropriate to ensure any negative impact on visual amenity was kept to a minimum.

Assessment

The key material planning considerations relating to the condition are discussed below. The principle of the development has already been established through the conditional approval of application 18NP0026.

Condition 6 (scheme for seeding and maintenance of track and turning area)

Condition 6 requires the submission of a scheme for the seeding of the surface of the track and its maintenance thereafter in the interests of visual amenity and the landscape character of the area.

The NNPA Landscape & Forestry Officer mentions in their consultation response that they are happy with the method statement for the construction of the access track, the subsequent reseeding and maintenance work identified. The Officer considers that the timescales proposed are appropriate for the scheme. It is therefore considered that the work set out in the submission when implemented is sufficient to discharge Condition 6 of application 18NP0026.

It is therefore considered that proposed scheme accords with the requirements of Core Strategy policy 20 and the NPPF.

Recommendation & Conditions

The details submitted in respect of condition 6 18NP0026 are **approved**, subject to implementation of the scheme in accordance with the plans and documents listed below.
