conditions 3:- no lighting is being used and so this is not applicable condition 4:- As per the landscape officers recommendation:- The Landscape Officer has noted that the seed mix will need to be able withstand vehicle use and has suggested the Emorsgate Standard Old Fashioned Grazing Mixture or similar. The Officer has noted that 35% Rye grass would give the required durability that will be needed mixed in with other traditional meadow species. He has recommended that that sewing and maintenance should be in line with manufactures recommendations with the Authority would wishing to see effective establishment (95% track cover) within two years of sewing. (i.e. if establishment fails due to dry weather then would expect applicant to re-sew next appropriate opportunity). The Ecologist has also confirmed that the above mix would be appropriate.
