Dear Jay,

I have looked at this application and the accompanying information and have the following comments.

It is proposed to remove one tree and crown reduce another for the construction of the tower and there is potential for some damage to the root zones of surrounding trees close to the proposed location during construction. The description of the birch to be removed does not sound as if this is an important tree within the plantation so I do not have any objections regarding this. If the measures in the tree report (including protective fencing and terram in the parking area) are conditioned I do think that the remaining trees will be safeguarded. The ecological survey does not suggest a likely ecological impact from the proposals, so if the mitigation given in that report is also conditioned (including leaving no open trenches and checking for squirrel dreys and badger setts prior to construction) I consider this to be acceptable.

The proposals are unlikely to affect the Hesleyside SSSI and the river due to distance and type of development. I note that as with previous huts firewood is provided so there will be no gathering of dead wood from the surrounding area which is good. I am content that a new package treatment system for waste water is acceptable.

I therefore have no objections to this proposal if the conditions above are applied.
