Dear Ross,

I refer to the above proposed works.

The proposals are adjacent to the River Breamish Site of Special Scientific Interest (SSSI) which is part of the River Tweed Special Area of Conservation (SAC), a European designated site. As such I have sought advice from the NNPA Ecologist. The Ecologist has advised that works that could impact on the features of interest of the SAC require a Habitats Regulations Assessment and that it would be for Northern Powergrid, as the Competent Authority under the Habitat Regulations, to carry this out.

This would require the provision of a method statement for the works. If it is intended to use concrete to fix the new pole the method statement should cover all the working methodologies to be employed to ensure that pollution of the burn from this activity is prevented. Measures to prevent silt entering the burn from any excavation works should also be covered as should the measures to ensure that there is no release of other pollutants to the burn (oil, diesel etc.) from the plant / machinery employed in the works. Providing the method statement is able to demonstrate there is no risk to the SAC interest features then the works could be screened out as having 'no likely significant effect' and we would then be in a position to sign the Certificate.

I hope this is clear and I look forward to receiving a Method Statement in due course. If you need any clarification, please feel free to drop me an e-mail (I am currently homeworking and this is the most reliable means of getting in touch).
