Notwithstanding the details being submitted it is not clear that what type of vehicle accesses the field at present.

The applicant should clarify the type of vehicle accessing the site together with its frequency. Should there be any vehicle trip activities associated with cattle transportation from one site to another required then details should be provided. This is important to know to enable a full and proper assessment to be made of whether the existing field gate access is appropriate or should access unpgrade work be required.

Sufficient information has not been provided at this stage in order to assess the highway safety or recommend access improvement works associated with this proposal.
